TORONTO RAPTORS SEASON SEAT HOLDER RENEWAL CONTEST OFFICIAL CONTEST RULES AND REGULATIONS ("Official Rules")

NO PURCHASE NECESSARY. THIS CONTEST IS SUBJECT TO ALL APPLICABLE FEDERAL, PROVINCIAL AND MUNICIPAL LAWS AND REGULATIONS AND IS VOID WHERE PROHIBITED BY LAW. PARTICIPATION IN THIS CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT WITH AND ACCEPTANCE OF THESE OFFICIAL RULES.

(1) **CONTEST PERIOD**: The Toronto Raptors Season Seat Holder Renewal Contest (the "**Contest**") begins at 12:01 a.m. ET on March 17, 2016 and ends at 11:59 p.m. ET on April 1, 2016 (altogether the "**Contest Period**"). The Contest will be further divided into "**Entry Periods**" as further outlined in Sections 3 and 4 below.

(2) ELIGIBILITY:

The Contest is only open to 2015-2016 Toronto Raptors Season Seat Holders of record who: (a) are legal residents of Ontario; (b) eighteen (18) years of age or older; or (c) are entrants, other than individuals, who have offices in Ontario, all at the time of entry (each an "**Entrant**").

Employees and the immediate families (including those with whom they are domiciled) of Maple Leaf Sports & Entertainment Partnership and Maple Leaf Sports & Entertainment Ltd. and their affiliates (collectively "**MLSE**"), the Toronto Raptors (collectively the "**Contest Sponsors**"), the National Basketball Association ("**NBA**") and its member teams, NBA Media Ventures, LLC, NBA Properties Inc. and each of their respective parents, governors, subsidiaries, affiliates, directors, officers, shareholders, employees and agents and their advertising and promotional agencies (altogether the "**Released Parties**") are not eligible to enter the Contest. For purposes of these Official Rules, "immediate family members" include: the spouse, son, daughter, brother, sister, mother or father of an individual.

(3) HOW TO ENTER:

NOTE: In order to be eligible for a particular Prize associated with a particular Entry Period (as outlined in Section 4 below), your Season Seats must be renewed prior to the applicable Entry Period Closing Date (see chart below).

There are two (2) ways to enter the Contest (each a "**Method of Entry**", resulting in an "**Entry**" or "**Entries**" depending on the method chosen):

(a) <u>METHOD 1: TORONTO RAPTORS SEASON SEAT RENEWAL</u>: During any Entry Period or the Contest Period, renew your Season Seats for the 2016-2017 Toronto Raptors Season ("Season Seats") by following the renewal instructions on the Toronto Raptors website at <u>www.raptors.com/seasonseats</u> (the "Website") or by telephone at 416-366-3865.

Each Entrant must review their individual Renewal Invoice (for specific costs), carefully read the renewal instructions on the Website and complete the Online Renewal Form on the Website. Entrants may then complete their Season Seat renewal by one (1) of the following four (4) payment methods, each resulting in the specified number of Entries into the Contest Draws listed below:

- i. <u>Payment in full (100%) of the cost of your Season Seats by credit card.</u> You must select the "Single Payment" option on or before April 1, 2016, when renewing your Season Seats. By signing up for payment in full by credit card, you authorize MLSE to charge your credit card for all 2016 Raptors home playoff games, following completion of each playoff round, as applicable. You will obtain two (2) Entries into the Draw using this Method of Entry.
- ii. <u>Payment in full (100%) of the cost of your Season Seats + Rounds 1 and 2 of the</u> 2016 Raptors playoffs by cheque. This first cheque for one hundred percent (100%)

of the cost your Season Seats + Rounds 1 and 2 of the 2016 Playoffs must be received on or before April 1, 2016. A second post-dated cheque for Rounds 3 and 4 of the 2016 Raptors playoffs must also be submitted at the same time, and dated May 2, 2016. All cheques should be mailed together. Cheques must be made out to Maple Leaf Sports & Entertainment Partnership and mailed to 50 Bay St, Suite 500, Toronto, ON, M5J 2L2, Attention: Ticket Service Team. You will obtain two (2) Entries into the Draw using this Method of Entry.

- Payment in six (6) installments for the cost of your Season Seats by credit card. Each installment of the cost of your Season Seats will be due and payable on the following dates: April 1, 2016 (20% of cost of Season Seats due); May 2, 2016 (20% of Season Seats due); June 9, 2016 (20% of cost of Season Seats due); July 8, 2016 (20% of cost of Season Seats due); August 11, 2016 (10% of cost of Season Seats due) and September 8, 2016 (10% of cost of Season Seats due). By signing up for installment payments by credit card, you authorize MLSE to charge your credit card for all 2016 Raptors home playoff games, following completion of each playoff round, as applicable You will obtain one (1) Entry into the Draw using this Method of Entry.
- Payment of the cost of your Season Seats by three (3) post-dated cheques. Cheque 1 must be for fifty percent (50%) of the cost of your Season Seats, plus Rounds 1 and 2 of the 2016 Raptors playoffs, and must be received by MLSE on or before April 1, 2016. Cheque 2 must be for the cost of Rounds 3 and 4 of the 2016 Raptors playoffs and must be post-dated to May 2, 2016. Cheque 3 must be for the remaining fifty percent (50%) of the cost of your Season Seats and must be postdated to August 11, 2016. All cheques should be mailed together to the address listed in Section 3(a)(ii) above. You will obtain one (1) Entry into the Draw using this Method of Entry.

Please note that, for each of the Methods of Entry listed above, twenty percent (20%) of your full payment or installment will be non-refundable and non-transferrable.

(b) <u>METHOD 2: NO PURCHASE MAIL-IN ENTRY</u>: Mail an original 250-word typed (not handwritten) essay about your favourite 2015 –2016 Toronto Raptors moment to: "Raptors Season Seat Holder Contest", 50 Bay St, Suite 500, Toronto, Ontario, M5J 2L2, Attention: Raptors Marketing. You must also include your name, address, daytime telephone number and email address with your essay. Limit of one (1) no purchase mail-in Entry per person, during the Contest Period. You will obtain two (2) Entries into the Draw using this Method of Entry.

There are a maximum of two (2) Entries per person during the Contest Period, regardless of the Method of Entry used, the number of Season Seats purchased, or the number of mail-in no purchase Entries submitted.

All Entrants must renew their Season Seats prior to the end of the Contest Period (or any other Entry Period Closing Date) in order to be eligible to win a specific (or any) Prize. No purchase mail-in Entries and cheques must therefore be mailed with sufficient time to be received by the Contest Sponsors prior to the end of the Contest Period (or any other Entry Period Closing Date) in order to be eligible for a specific (or any) Prize.

The Contest Sponsors accept no responsibility for Entries that are lost, misdirected or delayed for any reason. Proof of sending an Entry does not constitute proof of its receipt by the Contest Sponsors.

The Contest Sponsors reserve the right, in their sole discretion, to require proof of identity and/or eligibility (in a form acceptable to the Contest Sponsors – including, without limitation, government issued photo identification): (i) for the purposes of verifying an Entrant's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of an Entry entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Contest Sponsors deem necessary, in their sole discretion, for the purposes of administering this Contest in accordance with these Official Rules. All Entries shall become the property of the Contest Sponsors and none shall be returned. Each Entrant irrevocably assigns and transfers to the Contest Sponsors any and all rights, title, and interest in the Entry including, without limitation, all copyright in such Entry. Contest Sponsors shall have the right to edit or modify Entries for use in perpetuity and the Entrant waives any and all moral rights that he/she may have in the Entry. Each Entrant irrevocably confirms that no third party was involved in the creation of the Entry.

By entering the Contest, each Entrant agrees to be bound by the Official Rules and the decisions of Contest Sponsors, which are final with respect to all matters relating to the Contest.

(4) **PRIZES**:

***ENTRY PERIOD 4: NBA FINALS TRIP: ADDITIONAL CONDITIONS**

The Contest Sponsors reserve the right to refuse admission and/or to expel from ant game and/or any other aspect of a Prize, any person whose conduct is deemed by them to be objectionable. Expulsion from a game cancels the tickets for the offending individual(s) and the individual(s) thereupon forfeit(s) all claims with respect to the tickets. Participation in a Prize is subject to compliance with all applicable laws, by-laws, regulations and any applicable facility or carrier rules; failure to comply may result in non-admission or expulsion from further participation in the Prize.

Each Prize must be accepted as awarded, without substitution, and is not transferrable, refundable, for resale or, where applicable, convertible to cash, except in the sole discretion of the Contest Sponsors. The Contest Sponsors reserve the right, in the event that a Prize, or any component of a Prize, cannot be awarded as described herein for any reason, to substitute the same for another prize or component of equal or greater value, without notice or liability. (5) **WINNER SELECTION**:

Attempts will be made to contact each Selected Entrant between 9:00a.m. and 5:00p.m. ET during a period of three (3) days following his/her selection by the Contest Sponsors. If a Selected Entrant cannot be contacted or fails to respond within three (3) days, he/she will be considered to have forfeited his/her respective Prize and will be disqualified and another Entrant may be selected from the remaining eligible Entries until such time as contact is made with a Selected Entrant or there are no more eligible Entries, whichever comes first. In the event that an alternate Entrant is required to be selected, such Entrant will be subject to this same Winner Selection process. The Contest Sponsors will not be responsible for failed attempts to contact any Selected Entrant.

No telephone or email contact or other correspondence in connection with this Contest will be entered into except with the Selected Entrants.

The identity of the Season Seat Accountholder of record may be verified by Contest Sponsors in their sole discretion. In cases where the Season Seat Accountholder of record is a corporation or legal entity other than an individual, the Prize will only be released to a party who has the legal authority to bind the corporation or such other legal entity.

(6) **CLAIMING YOUR PRIZE**

To be declared a winner ("**Winner**"), each Selected Entrant must answer correctly, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question posed in a format of the Contest Sponsors' choosing. Each Selected Entrant will be required to sign a Declaration, Release and Waiver Form (the "**Release Form**") confirming compliance with the Official Rules, acceptance of his/her Prize as awarded, without substitution, and releasing the Released Parties from any liability in connection with the respective Prize or the Contest. The Entrant and Entrant's Representatives agree to fully indemnify the Released Parties from any and all claims by third parties relating to the Contest, without limitation.

(8) **LIMITATION OF LIABILITY**

None of the Released Parties assumes any liability for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the processing of Entries, the selection of Winners or for any printing or other errors in any Contest materials. The Released Parties assume no responsibility for any error, omission, tampering, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or authorized access to, or alteration of Entries. The Released Parties are not responsible for any problems, viruses or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of email on account of technical problems or traffic congestion on the Internet or at any website or combination thereof, including injury or damage to Entrant's or to any other person's computer related to or resulting from participating or downloading materials in the Contest.

None of the Released Parties assumes any liability for any personal injury or property damage or losses of any kind, including without limitation, direct, indirect, consequential, incidental or punitive damages which may be sustained to an Entrant's or any other person's computer equipment resulting from an Entrant's attempt to either participate in the Contest or download any information in connection with participating in the Contest or use of any website. Without limiting the foregoing, everything on any website is provided "as is" without any warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement.

(9) CONTEST ADMINISTRATION

All decisions regarding the Contest remain with the Contest Sponsors. The Contest Sponsors reserve the right, in their sole discretion, to modify, cancel, suspend and/or terminate any or all parts of the Contest, including the manner in which Prizes are distributed, for any reason. In addition, Contest Sponsors will not assume any responsibility of any nature whatsoever in all cases where Contest Sponsors' inability to hold the Contest or to remit the Prizes to Winners results from a cause beyond Contest Sponsors' control, including, but not limited to, Acts of God, weather conditions, strikes, lockouts or other labour disputes.

The Contest Sponsors reserve the right, in their sole discretion, to disqualify any individual found to be in violation of these Official Rules. The Contest Sponsors reserve the right to refuse an Entry from a person whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter.
